If you don't qualify on your own, your intended surety must complete an application form and pay the application fee so that we can perform **credit checks** on BOTH applicants. Steer & Co use TPN (*Tenant Profile Network*) to perform credit checks on all applicants and your signature on the application form provides us with permission to do so. By returning a signed application form you are also accepting the flat you have viewed AS IS. Please complete the form FULLY and write neatly and clearly with a black pen.

- Clear copy of ID document
- Non-RSA citizens to submit Refugee Status OR Passport copy AND work visa
- Clear copy of latest payslip
- If you are self-employed you must submit a letter from your accountant confirming your monthly salary
- Clear copies of bank statements reflecting a full 3 months
- Copy of proof of payment of R 200.00 (VAT incl.) to Steer & Co. For cash deposits send deposit slip copy, for EFTs send us confirmation of payment. The non-refundable fee covers the administrative cost of processing your application and does not guarantee approval of your application
- If a second person is applying, ALL the above documentation relating to this person must be sent
